



Dear Prof. Sugh,

The National Human Rights Commission has been actively engaged in the field of protecting and upholding the human rights of people since its inception under the Protection of Human Rights Act 1993. The Act mandates the commission to spread human rights literacy among various sections of society and promote awareness of the safeguards available for the protection of these rights through publications, the media, seminars, and other available means. In the series of this initiative, the commission also engages with the Educational Institutes to sensitize them about its mechanism of redressing of the grievances of the people whose human rights have been violated. The Educational visits are one of the opportunities for the students studying in the various colleges and universities of India to come to the NHRC and partake in the interactive sessions held by the NHRC.

- 2. In these educational visits, the NHRC officers, inform the students about the commission's role in shaping the Human Rights Framework in India for protection of the individual's Human Rights. This involves the briefing on the functioning of the mechanisms by which the human rights violations are taken into account, the manner in which the investigations are conducted in such cases of violation, and also the procedure for tracking and managing the complaints concerning the violation of human rights. These visits provide an opportunity to the students to get update about the recent initiatives by the NHRC, in terms of recent advisories or reports issued by the commission. The students also gain invaluable experience in the interactive sessions held by the senior officers of the commission.
- 3. To avail of this opportunity of educational visits at NHRC interested Universities and Colleges (covered under section 2 (f) and 12(B) of the UGC Act 1956) may apply for the educational visits at NHRC through the application portal available at the NHRC website.
- 4. In view of the above, if the colleges of your university are willing for the above-mentioned educational visits at NHRC, a detailed proposal about the visit of a team of students/faculty members may be submitted through the application portal available at our website www.nhrc.nic.in.
