- 1(a) A manufacturer produces three products X, Y and Z which he sells in three markets I, II and III. Monthly sales and sale prices are given as follows:

Market	Items Sold			Sale Price (Rs.)		
	X	Y	Z	X	Y	Z
I	10000	15000	20000	4.00	6.00	8.00
II	20000	28000	30000	5.00	5.60	7.40
III	30000	35000	40000	4.60	6.20	8.40

The cost per item for three products X, Y and Z are Rs. 3.60, Rs. 5.00 and Rs. 6.80 respectively. Find by matrix algebra the total profit of the manufacturer. (3)

- 1(b) In an engineering workshop there are 10 machines for drilling, 8 machines for turning and 7 machines for grinding. Three types of brackets are made. Type I brackets require 0 minutes for drilling, 5 minutes for turning and 4 minutes for grinding. The corresponding times for Type II and III brackets are 3, 3, 2 and 3, 2, 2 minutes respectively. How many brackets of each type should be produced per hour so that all the machines remain fully occupied during an hour? Solve by matrix algebra. (4)

- 1(a) Product 1 uses 3 units of material, 9 units of labour and 12 units of capital. Owls are becoming the latest target of illegal bird traders in India as they try ingenious ways to hoodwink the law with the demand for these nocturnal birds soaring in markets abroad. These birds of prey are important to the environment as they help control the rodent population by preying on them. This helps the farmers indirectly by keeping the rat and mice population under control.

Bird experts say that three species of owls that are at present in high demand are the Barn Owl, Great

Horned Owl and the Eurasian Eagle Owl. Each of the birds could fetch between Rs.3 lakhs and Rs.5 lakhs in the global market. There are around 22 species of owls found in India, including the three that have a high demand in the global market. If the illegal trade is not checked at the earliest, it could drastically bring down the owl population.

Poachers catch these birds from the wild to sell them to the traders. Thereafter the birds are smuggled by middlemen to Europe and the Middle East via Nepal and Bangladesh. These owls are mostly kept as pets, but they are also being increasingly used for all kinds of research purposes. After the green munias and rose-ringed parakeets, the owls seem to be now on the verge of extinction according to a study done by the Wildlife Trust of India (WTI).

Since the owls are bigger and weigh more than the parakeets, they are smuggled in ones and twos and not in bulk, making their detection by authorities difficult. Since each adult owl of the three species could weigh around three kilograms and can be easily spotted at airports, therefore, the traders smuggle the birds out of the country via road routes.

After the ban on the capture and trade in wild birds in the 1990s under the Wildlife (Protection) Act 1972 in India, the trade seems to have gone underground but has not ceased.

Mental health is described as a state of well-being where a person is able to cope with the normal stresses of life. This state permits productive work output and allows for meaningful contributions to society. However, different circumstances exist in our lives that may affect the ability to handle life's difficult situations. These factors may also disrupt daily activities, and the capacity to manage these changes. One such factor is childhood abuse. It occurs from a situation where a child is subjected to physical assault, sexual violence, emotional abuse or neglect in his formative period. As a result, the child grows up suffering from severe mental and emotional distress. Such experiences may also increase the risk of developing mental disorders like depression, anxiety, post-traumatic stress disorder or personality disorders. Children who may have suffered abuse may eventually deal with alcohol or substance use issues in their later years. But beyond mental health challenges, child abuse may also lead to medical complications such as diabetes, stroke, and other forms of heart disease. Sometimes adverse environmental circumstances, biological makeup or risky lifestyle behavior may also cause negative effects on psychological wellness in persons. In contrast, living in a positive social environment can provide protection against mental health challenges.

Mental health nevertheless greatly correlates with personal feelings about oneself. Confidence and self-esteem can often be a good indicator of a healthy mental state. Persons with a healthy mental state always focus on the good in themselves. They hone in on these qualities, have ambitions and aspirations that strive for a healthy, happy and fulfilling life.
