#### **Provided that:**

- a) The President should be final year student.
- b) The Vice-President and the Joint Secretary should not be final year student.
- c) Be between age of 17 and 25 years as on August 16th, 2023.
- d) Have attained 75% attendance.
- e) The candidate should in no event have any academic arrears in the year of contesting the election. Any pending paper(s) will be construed as academic arrear(s). Candidates failed in the preceding academic year and/or readmitted in the current academic year will not be eligible to contest the election.
- f) The candidate shall have one opportunity to contest for the post of officebearer, and two opportunities to contest for the post of executive member. No candidate can contest simultaneously for more than one post.
- g) Not have a previous criminal record, must not have been convicted of any criminal offence or misdemeanor. The student shall also not have been subjected to any disciplinary action.
- h) Abide by the code of conduct, as per the Supreme Court Judgment.
- i) Every candidate is required to furnish an affidavit, along with the Security Deposit, to the effect:
  - i) That he/she does not have any previous criminal record and has not been subjected to any disciplinary action by the University/College.
  - ii) That I have not failed in the preceding academic year and/or re-admitted in the current year.
- k) The maximum permitted expenditure per candidates shall be Rs. 5000/-.
- 1) Each candidate shall, within two weeks of the declaration of the result submit complete and audited accounts to the College/University authorities.
- m) Canvassing time for the DUSU Elections from 03:00 P.M. to 07:00 P.M. each candidate will have not more than 04 (four) bonafide students while canvassing in the College/Campus.
