Contractors who shall be found eligible after scrutiny of applications, documents, site visits to the earlier work, etc. shall be empanelled and tender documents for the proposed works shall be issued to them. No other advertisement shall be released for issuance of Bids. Motilal Nehru College (Evening) reserves the right to reject any or all applications without assigning any reason, thereof.

ELIGIBILITY CRITERIA

1. The contractors should be preferably based in respective location. They shall have minimum experience of 3 years in the field of executing similar works. Contractors who have executed similar work / empanelled with Banks, Financial institutions and Public Sector Undertakings will be preferred.

2. The contractor should have satisfactorily executed works of similar nature of following magnitude in last 3 years (ending with the last date for receipt of applications).

- a) Interior Work (The work executed should consist of interior works related to offices /consisting of partitions, workstations, cabins, furniture/furnishing items, storages besides related civil , plumbing and electrical works)

For works having Estimated Cost

- (i) Upto `20 lakh

One work costing atleast Rs. 16 lakh or 2 works costing atleast ` 10 lakh each

3. The contractor should have a professional reputation and the quality of works executed by the contractor should be of acceptable standard. The works assigned to them should have been completed within the prescribed time.

4. The contractors are required to attach the requisite satisfactory documents towards pre-qualification, along with their application. Failure to submit the same may result into rejecting the application.
